



CHILDREN CLIMB ON BOARD A MOBILE VISION CLINIC TO RECEIVE THEIR EYE EXAM FROM AN EYE DOCTOR AND HAVE THE CHANCE TO PICK OUT THEIR OWN FRAMES. THE GLASSES ARE MADE ON-SITE ON THE MOBILE CLINIC AND PROVIDED TO THE CHILD BEFORE THE END OF THE DAY.

IN 2017, THE KIDS VISION FOR LIFE PROGRAM PROVIDED 26,429 PAIRS OF GLASSES TO CHILDREN IN NEED ACROSS 8 MAJOR CITIES IN THE UNITED STATES.
